11. **Important Instructions for filling the Nomination Form.**

(Please fill two copies of the Nomination Form. One will be returned by Society duly stamped and signed as token of its receipt)

- (a) Write the full Name in the Serial No 1 of the form as written in the previous documents of the Society.
- (b) Write the name of father in Serial No 2 of the form. If not alive, write "Late" before the name.
- (c) Write full permanent address at Serial No 3 of the form.
- (d) Write present address of the member or if retired then write the appointment from which retired and present address in Serial No 4 of the form.
- (e) It is mandatory to write the name, relationship and age of family members in Serial No 5.
- (f) Signature, name age and address of two witnesses is essential and legally mandatory.
- (g) Obtain one copy of your nomination form from society office duly affixed with official seal and signatures of Society Official as a token of receipt.
